Ministry of Corporate Affairs (MCA) vide Order No. 24/2/2017-CL-III dated-22.05.2019 has sanctioned the amalgamation of West Bengal Waste Land Development Corporation Limited (Transferor Company) with West Bengal Forest Development Corporation Limited (Transferee Company) under section 230-232 of the Companies Act, 2013.

Now, therefore the Governor is hereby pleased to amalgamate of West Bengal Forest Development Corporation Limited with West Bengal Wasteland Development Corporation Limited with effect from 01.04.2018.

The administrative set up of West Bengal Forest Development Corporation Limited after merger of West Bengal Waste Land Development Corporation Ltd. shall be as follows:-

- 1) The Managing Director, West Bengal Forest Development Corporation Limited (Wbfdcl) shall remain the overall head. The works of erstwhile West Bengal Wasteland Development Corporation Ltd. would be executed by the wing called as "Green Projects Wing" under Wbfdcl.

The "Green Projects wing" would have the following structure until further orders:

- i) Chief Conservator of Forests(CCF)/Forest Conservation & Extension would head this "Green Project Wing" as Ex-Officio Chief Executive Officer and all officers of Parks & Gardens would be Ex Officio Officers of Wbfdcl Ltd. as they were earlier from Waste Land. For Plantation and timber harvesting works, senior and other Ex-Officio officers of Wbfdcl Ltd would be taken.
- ii) General Manager (GM) (Green Project Wing) Erstwhile GM (Operation) on contract and GM Ex-Officio/Conservator of Forests, Parks & Gardens (CF,P&G) of Wasteland would continue.
- iii) The accounts fixed and current assets of Wasteland Corporation would be treated as accounts of green projects wing of Wbfdcl under Ex-Officio, CEO & Dignitaries.
- iv) The support staff & assets as it was would be retained for till end of financial year 2019-20. In the mean time a Committee of Addl. PCCF cum GM/HQ, CEO, Financial Advisor and Company Secretary would work out details and submit report by December, 2019 for restructuring the entire functioning in Wbfdcl of all activities of Wasteland Corporation from Financial Year 2020-21 onwards.
- v) All the existing projects and future projects under Green Project Wing as undertaking of Wbfdcl will continue in the same modus operandi were being implemented before merger.
- vi) The designated officers of the Forest Directorate who shall act as the as ex-officio officers of Wbfdcl is given at Annexure-I.
- vii) The existing DFO's, who have been designated as ex-officio DM/Wbfdcl shall continue to act in the same manner.

The above administration arrangement will continue until further orders.




