#### ORDER

The undersigned is directed by order of the Governor to say that the matter of revision of payment of compensation for the loss of life and property due to depredation by wild animals has been reviewed by the State Government.

The Governor is now pleased to accord sanction that ex-gratia grant will be given to the victims or the legal heirs of the victims of depredation caused by wild animals in the scales shown in the table below.

| Sl No. | Categories  | Rate  |
|--------|---|---|
| 1      | To the family of the deceased for loss of life                        | Rs. 5.00 lakhs Subject to certification regarding cause of death from appropriate authority   |
| 2      | Permanent Disability making person unfit for any physical work        | Rs. 2.00 lakh   |
| 3      | Permanent loss of sight in both eye, loss of hearing in both ear      | Rs. 1.00 lakh   |
| 4      | Permanent Loss of sight in either eyes, loss of hearing in either ear | Rs. 0.50 lakh   |
| 5      | Permanent impairment of any limb or joint                             | Rs. 0.50 lakh   |
| 6      | Grievous injury requiring hospitalization                             | Rs. 50,000/- per person requiring hospitalization for more than a week plus free medical treatment in govt. hospital.  Rs. 25000/- per person requiring hospitalization for less than a week plus free medical treatment in govt. hospital. |
