27) **Qualification criteria:**

The tender inviting and Accepting Authority through a "Tender Committee" will determine the eligibility of each Bidder. The Bidder shall have to meet all the minimum criteria regarding:

- 1) Financial Capacity
- 2) Technical Capacity comprising of personnel & equipment capability
- 3) Experience / Credential

The eligibility of a Bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in (a), (b) & (c) above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarize. If any document submitted by a Bidder is either manufactured or false, in such cases the eligibility of the Bidder / tenderer will be rejected at any stage without any prejudice.

- 28) Escalation of price on any ground and consequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly. A Tenderer is required to quote rates in figures as well as in words.
- 29) The payment for the works will be made by the undersigned in 2017-18 financial year after fulfilling the necessary official formalities and checking.
- 30) The Construction of the project work as mentioned in the schedule will have to be undertaken immediately on receipt of work order and the work must be completed as mentioned in the work order.
- 31) No extension of time will be allowed under any circumstances.
