Aranya Bawan, LA – 10 A, Sector – III, Salt Lake City, Kolkata – 700 098.

All interested Tenderers shall have to deposit an Earnest Deposit (EMD) of Rs.1000/- (Rupees One Thousand Only) through Demand Draft, drawn in any Nationalised Bank in favour of Deputy Conservator of Forests, Publicity, West Bengal or through GRIPS. Without which submitted tender will be treated as cancelled.
