GENERAL TERMS AND CONDITIONS

- 1) In the event of e-filing, intending bidder may download the tender documents from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. **Earnest Money Deposit (EMD)** is to be done through online by the Tenderer vide Finance Deptt.'s Order No. 3975-F(Y), Dt. 28.07.2016. Please note that further details, contact Divisional Forest Office, Durgapur Division, Aranyapally, Shastri Avenue, Bidhannagar, Durgapur-12 Ph.No. 0343-2537229 on working day from 05.07.2018 to 13/07/2018.
- 2) Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly Digitally signed in the website <https://wbtenders.gov.in>
- 3) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in **Schedule of Dates**
- 4) The **FINANCIAL OFFER** of the prospective Tenderer will be considered only if the **TICHNICAL BID** of the Tenderer is found qualified by the **Tender Committee** under the Tender inviting Authority i.e. **“Divisional Forest Officer, Durgapur Division, Directorate of Forests, Government of West Bengal.** The decision of the, Tender Committee will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.
- 5) **Eligibility criteria for participation in the tender.**
 - i. All categories of Contractors / Labour Co-Operative Society / Registered Co-operative Societies having experience in preferably similar type of works in addition to the above, any contractor who has executed any type of Tender or e-Tender works in Directorate of Forests, Govt. Of West Bengal, should submit previous credentials for his past performance, completion certificate from respective employer, the completion certificate and credentials should be signed by the officer not below the rank of Deputy Conservator of Forest, any other certificate signed by other officials will not be entertained (Non Statutory Documents).
 - ii. All categories of contractors/ Labour Co-Operative Society / Registered Co-operative Societies having valid credential during the last 3 (three) years (2015-16 to 2017-18) from the date of issue of this notice at least one work of preferably similar nature **as a prime agency** under authority of State/Central Government, State/Central Government Undertaking / Statutory bodies Constituted under the Statute of the Central/State Government at least in the magnitude of 50 % (fifty percent) of the amount put to tender.
 - iii. Registered Unemployed Engineers“Co-operative Societies having credential during the last 3 (three) years from the date of issue of this Notice at least one work of preferably similar nature as a **Prime agency** under authority of State / central Government undertaking / Statutory Bodies Constituted under the Statute of the Central / State Government at least in the magnitude of 50 % (fifty percent) of the amount put to tender.

 - iv. Income Tax Acknowledgement Receipt for the latest Assessment year, P.T. Deposit Challan for the year **2017-18**, Pan Card, GST Registration Certificate, Tread License are to be accompanied with the Technical Bid Documents.
