Sealed quotation is invited from bonafide agency/ Govt. Contractors/ Companies having Trade License, GST No., Pan No. and valid Account .The following conditions will be applicable for quoting the rates for the above work.

Terms & Condition:-

1. The agency/ Govt. Contractors/ Company preferably to be local of Cooch Behar District or the locality with previous experience of similar type of work.
2. Exact location/ to be confirmed by the concerned Range Officer and accordingly the quotationer has to work.
3. The rate is to be quoted for entire work which includes material loading and unloading as per specification.
4. The agency/ quotationer will submit bill within 7 days from the completion of supply in triplicate to the undersigned. The bill as prepared will be submitted to Jalpaiguri Treasury from where the amount will be directly transferred to the account of the quotationer. The payment will be made as per availability of fund.
5. The lowest quotation may not be accepted if all the conditions are not fulfilled/ unjustified rate is quoted/ and undersigned is not satisfied. Quotation will not be accepted if the authority feels it is incomplete. If any quotation is rejected no correspondence will be entertained.
6. Income tax and other taxes, as applicable will be deducted as per existing rules.
7. The Department will not take any responsibility if any accident happens during the supply and the quotationer will be solely responsible for providing safety to the labours/workers who is/ was deputed for this particular work.
8. The above mentioned works are to be completed as per work order. If the performance and quality of work is not satisfactory, work order and rate acceptance order will be cancelled and undersigned decision will be final
