Auction Notice

(Notice Inviting Quotation for disposal of old condemned Departmental Vehicle)

Sealed quotations are invited for the disposal of old condemned departmental vehicles on the terms and conditions method below. Interested parties may submit their highest quotation in the proforma annexed to this notice. The quotations in sealed envelope should reach at the address by name as well as official designation "**Shri Milan Kanti Mandal, WBFS, Divisional Forest Officer, Durgapur Division**" on or before 24.12.2018 up-to 01:00 PM. The envelope should be prominently super-scribed with the words "**QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE**". The vehicle will be available for inspection at respective Range and Divisional Office on all working days (Monday to Friday) between 10:00 AM to 05:00 PM as mentioned in the table below :-

1. The quotations received in time will be opened by the Tender Evaluation Committee on 24.12.2018 at 12:00 PM in Divisional Forest Office, Durgapur Division. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of Quotations.
2. The sale will be Governed under following conditions-
 - i) The bidder is required to pay Earnest Money of Rs 5000.00 (Five Thousand) only, along with quotation through Bank Draft, payable in favour of "**Divisional Forest Officer, Durgapur Division**" payable at '**Durgapur**', which will be returned to unsuccessful bidders on completion of auction.
 - ii) Quotation received without Bank Draft towards Earnest Money will not be considered at all and will be liable to be rejected immediately.
 - iii) The successful bidder will be required to deposit the total bid amount by means of Bank Draft payable in favour of "**Divisional Forest Officer, Durgapur Division**" within next 02 (two) working days of the acceptance of the bid.
 - iv) Earnest Money will be forfeited, if the successful bidder fails to honour the bid within reasonable time. The Earnest Money of the successful bidder will be released only after submission of proof of transfer of Vehicle Registration in his name.
 - v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. AADHAR Card/Ration Card/Voter Identity Card/Passport etc. In case of individual and registration certificate in case of firm etc.
 - vi) The sold vehicle will be cleared by the successful bidder from the premises which are mentioned in the Auction Notice within two working days after issue of sale/delivery letter by the Divisional Forest Officer, Durgapur Division at their own expenses.
 - vii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at own cost expeditiously. The Divisional Forest Officer, Durgapur Division will not be responsible for any lapse on his part in this regard.

- viii) The vehicle will be disposed of 'as is where is' basis and no guarantee for its worthiness or quality will be given by the Divisional Forest Officer, Durgapur Division.
- ix) The bidders are not allowed to withdraw their bid till the completion of auction process, failing which their Earnest Money will be forfeited.
- x) The competent authority has the right to accept or reject any/all the quotation without assigning any reason.
- xi) Employees of Divisional Forest Office, Durgapur Division and their family members are not eligible to participate in auction bid.
