- Supplier must be a bonafide entity or an Authorized Dealer.
- Supplier must have proper trade licence & PAN & GST Clearance till 31.03.2018.
- The Poly Propylene rope to be supplied should have exact specification of Strand PPARA 4mm yellow colour (ISI 5175 1992) and price is to be per kg.
- Supply should be made up to Raidighi Range Office at HQ including carriage and rates to be quoted accordingly. Rates should be exclusive of GST and GST should be mentioned separately in the tender.
- Supply should be made as & when necessary within 15(Fifteen) days of issuance of letter of acceptance and work Order.
- The Divisional Forest Officer, 24 - Parganas (South) Division reserves the right to reject any or all the Tenders or any condition of the Tender Notice without assigning any reason.
- The Divisional Forest Officer, 24 Parganas (South) Division is not bound to accept the lowest rate.
- All intending Tenderers shall have to deposit an Earnest Money Deposit of Rs.1,000.00 (Rupees one thousand only) in the form of 'GRIPS' portal of Govt of West Bengal in compliance with Finance Department, WB's memo no 3667-F(Y) dated 14.07.2014. He will submit the bank receipt challan along with tender document as a proof. The EMD will be released to the unsuccessful Tenderers on written application after successful completion of all formalities of the tender. If the successful Tenderer fails to execute the required Agreement within the stipulated period, the EMD will be forfeited to the Government. Release of EMD will be done on line through treasury on completion of all formalities. The EMD will be released to the unsuccessful tenderers on written application after 15 days from successful completion of all formalities of the tender.
- EMD of the successful tenderer cannot be adjusted against the security deposit.
- If the successful Tenderer fails to execute the required Agreement within the stipulated period, the EMD will be forfeited to the Govt.
- The successful tenderer shall have to deposit the "Security Deposit" of Rs. 10000.00 (Ten thousand only) in the form of 'GRIPS' portal of Govt of West Bengal in compliance with Finance Department, WB's memo no 3667-F(Y) dated 14.07.2014.
