USE AND PROTECTION OF USER ID, PASSWORD AND DIGITAL SIGNATURE ERTIFICATE:

The bidders are advised to keep their User ID and Password secret and not share these with anyone to prevent misuse or abuse of the same. The bidders are also advised to change their passwords regularly. NIC/Divisional Forest Officer, Birbhum Division shall not be responsible for any misuse/abuse/unauthorized use of the password of any bidder and no representation in this regard from any bidder shall be entertained by NIC/Divisional Forest Officer, Birbhum Division. A bid recorded in this e-auction against any password will be deemed to have been submitted by the owner of the password only. Bidders shall require Class II or Class III Digital Signature Certificate (DSC) to participate in this e-auction. The bidder shall have to set the parameters of his computers so that the DSC is operational.NIC/Divisional Forest Officer, Birbhum Division shall not be responsible for any malfunctioning or non-functioning of any bidder's computer either on account of DSC or for any other reason. Bids submitted by a bidder after signing with his/her DSC signifies non repudiation by the bidder. Thus, a bidder after submitting a bid cannot disown it. A bidder shall be fully and solely responsible for the bid recorded against his/her name to be identified by the set of User ID, Password and DSC.

BIDDING METHODOLOGY

On the day of the e-Auction, which will be started on 28.02.2018 (Details in Table – II). Subject to auto extension, the bidder has to visit the Government e-auction website https://eauction.gov.in and click on the link for Divisional Forest Officer, Birbhum Division e-auctions. He/she has to login with his/her User ID and Password. In the next page, the bidder has to click on the link "View Live e-auctions" and click on the link with the e-auction number for this e-auction. The bidder shall be required to sign his acceptance of e-auction terms and conditions with his DSC and then only the bidder can have access to the biding area. The bidding for the vehicles (Four wheelers) shall be in whole Rupees. Thus to bid an amount of Rs. 50000 (Fifty Thousand), a bidder needs to type 50000 in the space provided for bidding and click on the BID button. On clicking the BID button, the bid as to be signed by the bidder with his DSC. The incremental value is Rs. 500% (Rupees Five Hundred) only.

AUCTION IN SUBMISSION OF BID

The Bidder shall be solely responsible for all consequences arising out of the bid submitted by him (including any wrongful bidding by him) and no complaint/representation will be entertained by NIC/Divisional Forest Officer, Birbhum Division in this regard. Hence Bidders must be careful to check (the BID Amount/NO. of Zeros/No. of Digits/Unit of Measurement etc.) rectify their bid (if required) before submitting their Bid into the live e-auction floor by clicking the 'Bid'Button.

The Highest Bidders should pay for purchasing vehicles the sale value + 18% GST + 1% TCS and any other taxes as per existing norms.

Terms & Conditions

A. Technical:

- Bidder will be considered for evaluation only if required EMD in original is deposited within prescribed time limit in the office of the Divisional Forest Officer, Birbhum Division.
- Original Documents if any asked by the Divisional Forest Officer, Birbhum Division should be produced immediately by the bidder
- No bidder shall be exempted from payment of E.M.D. and E.M.D. Exemption given by other Department will not be accepted. Offer submitted without E.M.D. will not be accepted.
- 4. ACCEPTANCE OF e-auction:

Acceptance of e-auction will rest with the authority, who reserves the right to reject any or all e-auction without assigning any reasons. The e-auction whose offer is accepted will have to complete the contract form within 15 days of being notified to do so and shall abide by all the rules and regulations and special conditions enumerated therein or attached herewith.

5. VALIDITY:

The offer shall remain valid for a period 60(Sixty) days from the date of the opening of e-auction.

B.Taxes:

- 1. GST @ 18% will be charged on bid value.
- The maximum offered rate is net value of the goods to be sold. Taxes in respect of Sales by transfer of property in goods involved in the execution of work.
- Income Tax (Tax collected at source & surcharge as per section 206(c) of the Income tax Act) will be payable by the Auction purchases (Or applicable).
- 4. All Tax, Turnover tax, excise duty and all other taxes, duties (Imposed) payable to the Central Government or to the State Government must be paid by the successful Auction Purchaser to the Divisional Forest Office, Birbhum Division along with accepted purchased price.

C) Payment Terms:

- 1. On Completion of bid and issue of letter of AOC, the successful bidder will be intimated from this office about the procedure of payment of bid value, last date and time of payment of total bid value. The Bidder should ensure that he pays the bid value due in time and lift the vehicle within stipulated period, thereafter. If successful Purchaser fails to deposit Bid Amount, his EMD will be forfeited and further he will be disqualified for the participation in further e-auction's of Forest Department.
- 2 The vehicle should be lifted by the successful Auction Purchaser from the location of the concerned office of the Department within 10 days after making the payment of sale value. In case of failure to lift the vehicle within the above-stipulated period, penalty of 1% (One Percent) of the accepted bid value per day will be charged towards ground rent by Divisional Forest Officer, Birbhum Division. Bidder to lift the Auctioned vehicle as early as possible. Department will not be responsible for any theft or damage to vehicle after issue of AOC.
- If the Auction vehicle is not removed within 60 days from the date of auction, the competent authority will reserve the right to cancel the auction in which case the bid amount will stand forfeited.

D) General:

- Bidders will have to make one time enrolment on e-auction site https://eauction.gov.in
- For enrolment on the website bidders have to register their Digital Signature Certificate
- Bidders shall upload scanned copies of personal details, technical documents along with declaration in schedule time on specified site https://eauction.gov.in
- The bidder has to submit the auction document online well in advance before prescribed time
- Any change in auction schedule or auction term & condition will be available online on e-auction website. Department will not be responsible for ignorance of bidder to any updates in website
- The bidder should see that the bid document/bid submitted should be free from virus &
 if the document could not be opened during auction opening the bidder enrolment/bid
 is liable to the rejected
- After evaluation of bidder document, only approved bidder will be allowed to participate in live e-auction process
- Bidder should log into the site well in advance for bid, submission so that he submits
 the bid in time i.e. on or before the bid submission end time. The bidder shall only be
 responsible for any delay due to other issue whatever it may be-
- Department will not be responsible for any kind of failure of network & computer from bidder side

10. If any bid is received during the last 5 min before schedule close of auction for any source, its close time will get automatically extended by 5min from the time of last bid in order to give all the bidder equal chance to revise their bid

Bidding will close for a particular source either at the scheduled close time or till there will be period of 5min in which no bid is recorded for the source, whichever happen late

11. The auction able vehicle shall be disposed off in "AS IS WHERE IS" basis.

It is expressly understood that the bidder is fully satisfied himself regarding the quality, quantity & condition of auction able vehicle before bidding. The disposable vehicle are normally kept in the yard in open space and the Divisional Forest Office, Birbhum Division will not be responsible for any damage/deterioration of the vehicle.
