Sealed Tender (to be addressed to the undersigned by name and not by his official designation only) are invited from the bonafied supplier for supply of Meat (beef) to Captive leopard population at Rasikbeel Mini Zoo, Rasikbeel under Coochbehar Division.

The Tender should reach to this office by 02:00 P.M on or before 13/07/2017 and will be opened on the same date at 03:00 PM. Tender should reach by post or by hand to this office as stated above. The Tender will be opened by the Ex-Officio Director, Rasikbeel Mini Zoo & Divisional Forest Officer, Coochbehar Division, Coochbehar in presence of such of the Tenderers as may be present.

CONDITIONS.

1. The Tender is to be submitted by name to Sri Biman Kumar Biswas, WBFS, Ex-Officio Director, Rasikbeel Mini Zoo & Divisional Forest Officer, Coochbehar Division, P.O. & Dist. - Coochbehar, and not by his official designation only. Filled in Tender forms should be closed, sealed and superscripted with the words "TENDER FOR SUPPLY OF MEAT (BEEF) FOR CAPTIVE LEOPARD POPULATION AT RASIKBEEL MINI ZOO, RASIKBEEL for the year 2017-18 ". The price must be mentioned against the item specified per Kg. including delivery at Rasikbeel. The materials should be fresh, clean and of best quality. If the supply is found to be inferior one, the Tender even approved and accepted will be cancelled and security money will be forfeited to Government without any notice to the supplier.
2. Every Tenderer shall enclose with his Tender paper, valid VAT clearance certificate and Professional Tax Certificate from Officer concerned, failing which the Tender will be rejected.
3. Intending Tenderers are requested to submit application for Tender papers positively on 03/07/2017 & 04/07/2017 upto 02:00 P.M.
4. Tender papers will be issued on 05/07/2017 & 06/07/2017 upto 03:00 P.M. Last date of receiving Tender papers is 13/07/2017 upto 02:00 P.M. Tenders will be opened on 13/07/2017 at 03:00P.M.
