The fund has been allocated @ `5.00 Lacs (*Rupees Five Lacs*) only for each division. However, you are free to club 'Ban-Bandhab Utsav' of 2 (*two*) places into one and increase the sum up to `10.00 Lacs for organizing the 'Ban-Bandhab Utsav'. After the event, a report along with the photographs etc. should be sent to the DCF, Publicity, West Bengal.


