To facilitate efficiency, data transfer and compilation, a software module has been developed called

'Biennial Status Report'. The URL is "reportbr.wbforest.org". The site can also be accessed from the

website of Forest Department under "For Officers". User ID and Passwords are enclosed. All officers

are requested to upload the data as per time schedules.

For the period April to September, 2017, a one time extension is given till 20th of January, 2018.
