Sub: Online Tender Fees/EMD in e-Tender Portul

Online receipt and refund of EMD and Tender Fees, as applicable, on the State Government's e-Procurement Portal (https://wbtenders.gov.in) through the linked Payment Gateway has been made mandatory vide FD's Memo No. 3975-F(Y) dated 28.07.2016.

- 2. It has come to the notice of the State Government that some of the State PSUs/Autonomous Bodies/Local Bodies/Parastatals under the administrative control of the State Government are not observing the procedure for online receipt and refund of EMD/Tender Fees as prescribed in the Memo, ibid. This is not in line with the e-Procurement Policy of the State Covernment.
- 3. Therefore, it is clarified that in case any entity under the State Government including ? Autonomous Bodies/Local Bodies/Parastatals does not follow the prescribed procedure for online receipt and refund of EMD/Tender fees, such tender shall not be treated as valid. 7
