Sub : Information regarding Gitanjali EWS Housing Scheme

Sir / Madam,

The Gitanjali 'EWS' Housing Scheme / Amar Bari was executed by the Forest Directorate since 2009-2010 to 2015-16. Since the allotment of units and funds was made directly to the divisions, all relevant informations / documents for all the years are not available with WBSFDA. Also as the fund was not moved through WBSFDA, except in one or two special cases, therefore, the major correspondences regarding release of fund and expenditure accounts are not available. Revalidation of sanctioned amount, inability to take up work due to late sanction has made the matter more complicated.

Now, however, the onus of squaring up the matter of 'Gitanjali Scheme'—through submission of UC & PR—lies with the WBSFDA. To do this WBSFDA would require all informations pertaining to 'Gitanjali Scheme' from all implementing Divisions as per the format provided. We require the reports in hard as well as editable soft copies and ALL LOCs AND RELEVANT SANCTION ORDERS IN HARD COPIES.

Please endeavour to send the informations within the 30th of November, 2018.
