OFFICE ORDER

WHEREAS, in a meeting held on 13th of June, 2018, it was decided to constitute a small committee for recommending the solution related to the disposal of lops & tops from the felling areas; *and*,


WHEREAS, in the said meeting it was decided that the sale value of such lops & tops will be deposited with West Bengal Forest Development Corporation Ltd.

NOW, after reconsidering the matter, it is hereby decided that the sale value of the lops & tops **need not be deposited to the West Bengal Forest Development Corporation, as there will be no JFMC share from the sale of such produce and the entire sale value will come back to the Directorate of Forests.** So, the revenue collected from the sale shall be deposited as revenue through GRIPS portal.
