### ORDER

Whereas many seized/ confiscated Vehicles are lying in various premises of Forest Dept. for several years, occupying space.

Whereas the Principal Secretary forest Department Government of West Bengal in his D.O. Letter No 12/PrSF/18 dated 26.04.2018 addressed to the Principal Chief Conservator of forests & Head of Forest Force, West Bengal has requested to draw a schedule for condemnation of the seized/confiscated vehicles and their auction with a deadline and to complete the entire process.

It is hereby ordered that the seized/confiscated vehicles under the custody of forest Divisions, should be auctioned following due process, by respective DFO, following existing rules. The time schedule is given below.

- (I) Preparation and submission of division wise and location wise inventory of the seized /confiscated vehicles to the PCCF & HoFF (by the DFO/DFD) **within 15.06.2018.** ( the proforma in which the report to be submitted is given in Talbe A)
- (II) Completion of the procedure of condemnation of the vehicles seized/confiscated vehicles following the relevant GO(s) of the Transport Department ..... **within 15.08.2018.**
- (III) Completion of the procedure of auction of the vehicles seized/confiscated within 15.09.2018

A Completion report should be sent by the respective DFOS for record in this office.
