In partial modification of Office Order number 19–A/PMC/2018 dated 08–06–2018 of the Additional Principal Chief Conservator of Forests, Human Resource Development, West Bengal, following 23 (Twenty–three) incumbents; are appointed to officiate as Forest Guard on temporary basis, with effect from forenoon of 11th June 2018 and/ or date of their joining subject to the condition of their joining the posts. The incumbents are entitled to get pay in the scale of Pay Band 2 of Rs. 5400 – 25200/- with Entry Pay @ Rs. 5400/- & Grade Pay @ Rs. 1900/- plus allowances as admissible from time to time under existing rules and orders of the Government in accordance with following terms & conditions.

- 1. That the present posting is purely temporary.
- 2. That the appointment is terminable at any point of time within first three years with a notice of one month or a payment of salary of one month in lieu of, if the appointee's conduct and/ or performance has not been found satisfactory or up to the marks.
- 3. All service related matters will be governed by relevant rules & regulations, applicable to employees of same category of the Government, W. B.
 - 4. The service is transferrable throughout the state of West Bengal.
- 5. If the appointee wants to resign for any reason, he/ she should have to serve notice of one month to this appointing authority as per Rule 34A of West Bengal Service Rules Part I.
 - 6. No T.A/D.A. shall be paid for their joining at the stipulated joining point.

All 23 (Twenty-three) incumbents have been selected on basis of result of the FG Recruitment 2017; conducted by the West Bengal Police Recruitment Board, West Bengal; and allotted by the said Board to the Directorate of Forests, Government of West Bengal for appointment to the post of Forest Guard and having satisfactory verification of antecedents & medical examination by the competent authority
