**OFFICE ORDER**

Whereas the ad hoc Compensatory Afforestation Fund Management and Planning Authority vide their letter No. 13-20/2015-CAMPA dated 9<sup>th</sup> June, 2016, had clarified that the funds realized from the User Agencies for felling and removal of trees from forest land diverted and the fund deposited for demarcation of the boundaries of forest so diverted is required to be deposited with the concerned DFOs and that the works are to be taken up Departmentally, and


Whereas, this Office, vide Office Order No. 68-Misc/CAMPA/16 dated 4.10.2016 had directed that the funds received from User Agencies from felling, logging and transportation of timber standing on diverted forest land is required to be deposited in the Civil Deposits of the concerned DFOs under Head of Account 8443-00-109-Forest Deposits -002 for deposit works -07-Deposits, and

In view of the above considerations, and with a view to expedite the execution of the works, the earlier Office Order dated 04.10.2016 has been reviewed and it is hereby ordered, in partial modification of the earlier Order No. 68-Misc/CAMPA/16 dated 04.10.2016 that the funds received from the User Agencies are to be deposited in account of WBSFDA.

The State CAMPA will intimate the User Agency as well as the WBSFDA the amount to be deposited by the User Agencies, mentioning the name of the project, name of the user Agency shall provide a list of the Divisions and amounts meant for each Division, project wise, with copy endorsed to the concerned User Divisions.

The User Agency will submit copy of receipted challan after payment of the money from the concerned bank as proof of depositing the money with WBSFDA account.

On receipt of the money, the WBSFDA will arrange to disburse the amounts to the concerned Divisions as intimated by the State CAMPA.


