All States Governments and Union territory Administrations**Sub: Review of time taken by the various processing authorities in the States/UTs to process the proposal submitted online on PARIVESH 2.0 vis-à-vis timelines prescribed under Van (Sanrakshan Evam Samvardhan) Rules, 2023 – reg.**

Madam/Sir,

I am directed to refer to the above mentioned subject and to inform that recently an exercise to review the time being taken by the various processing authorities of the State/UTs to process the proposals submitted online on PRIVESH 2.0 was undertaken by the Ministry. It was observed that time lines prescribed in the Van (Sanrakshan Evam Samvardhan) Adhinyam are not being adhered to by the processing authorities in the State/UTs. In many cases, time being taken by the processing authorities is almost 2 times of the time lines prescribed in the rules. States/UT wise detail of time taken by the various authorities is enclosed herewith. Given the time consumed in processing the proposal by various authorities, the purpose of online process as envisaged under the Van (Sanrakshan Evam Samvardhan) Rules, 2023 is not being served fully. The matter has been viewed very seriously in the Ministry and it was desired that all processing authorities in the State/UT should strictly adhere to the prescribed time lines as provided in the rules.

2. Therefore, to ensure smooth implementation of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, it has been desired by the Ministry that regular review by the Principal Secretary (Forests) or PCCF & HoFF may be conducted to assess the time being taken by the various authorities in processing the proposals and strict warnings against the officers not adhering to the time lines may be issued by the State/UTs.

3. Accordingly, I am directed to request the State Government and Union territory Administrations to ensure strict adherence to time lines provided in the rules, as mentioned above, and a report on the regular reviews may be submitted to the Ministry for further necessary action in the matter.
