The rates of royalty of various minor minerals have been revised vide Notification No.01-CI/O/MIN/GEN-RLT/02/2015, dated 03.01.2022 and Notification No-581-ICE-12013(99)/6/2022-MINES SEC-Dept. of ICE, dated 26.09.2022 of the Department of Industry, Commerce & Enterprises (Mines Branch), Government of West Bengal (copy enclosed) and the copy of the said notifications were forwarded to all the Chief Engineers of I&W Directorate for taking necessary action with regard to preparation of estimates vide this Department's memo no. 192-IRC dated 06.12.2022(copy enclosed).

2. Since the aforesaid notifications do not contain royalty charges for minor minerals, extracted from quarries in forest area, the applicability of royalty charges of minor minerals from forest area was taken up with the State Forest Department recently.

3. The State Forest Department has informed to follow the applicable charges against the minor minerals (Stone Boulder, Gravel, Shingles and Sand Boulder) quarried from forest area in West Bengal, as stated below :-

4. The said applicable charges are also to be treated as royalty of minor minerals, extracted from forest area.

- Rate of Forest Produce (boulder / gravels / pebbles / shingles etc.) which is same as royalty = Rs. 75/cum
- Entry Fee/Forest Road Usage Fee
= Rs. 500/Truck (upto 6cum) i.e; Rs. 83.33/cum
or
= Rs. 1000/Truck (more than 6cum and upto 12cum) i.e; Rs. 83.33/cum
- Transit Pass Fee = Rs. 20/cum

Total applicable charge per cum (a+b+c) = Rs. 75 + Rs. 83.33 + Rs. 20 = Rs. 178.33.

5. Henceforth, while preparing estimates, the above rates of applicable charges(including royalty) of boulder/gravels/pebbles/shingles etc. extracted from forest area are to be followed. All the submitted DPRs, presently under the appraisal of DLTC/Committee of Chief Engineers/DSC, are to be revised before accordance of AAFS.
