- 7. The payment will be made after receiving the satisfactory completion report from concerned Range Officer & Payment will be made only after receipt of fund from Competent Authority.
- 8. The Quotationer may visit the place of work before quoting rate, if applicable.
- 9. Maximum time limit for completion of work 15 days for any supply related work and 25 days for any construction related works.
- 10. The security deposit @ 10% on the Project Cost may have to be deposited if mentioned in the Work Order through "Demand Draft" in favour of "Divisional Forest Officer, Parks & Gardens (North) Division" before submission of final bill. The Security deposit will be release to the successful contractor within 3 (Three) months after successful completion of work provided no irregularities are noticed during this period.
