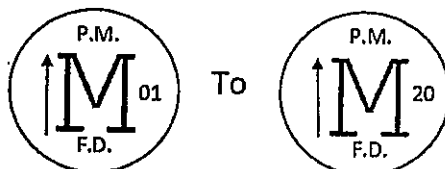
Sale Marking Hammer (Diameter 50 mm.)

Passing Hammer (Diameter 50 mm.)




Marking Hammer (Diameter 50 mm.)
