ANALYSIS OF THE ESTIMATE & PRE-REQUISITE SPECIAL CONDITIONS

- 1. Model estimates for creation works of Sal & QGS plantations for the F.Y 2024-25 have been provided above. The estimated cost is inclusive of all materials to be supplied & labours to be engaged for the purpose. Successful bidder/s should carry out the works either by deploying machine or by deploying labours from local JFMS s only by paying minimum wage for the time in vogue. As, each of the activity requires specialized skill and experience, JFMC members who are conversant in carrying out such types of activities should be given preference while deploying labour such types of jobs. While payment is required to be made by the contractor concerned, decision taken by the concerned Range Officer on technical ground shall be final and binding with respect to carrying any particular activities mentioned in the model estimates. All seedlings to be planted will be supplied from the concerned Central/Field nurseries.
- 2. The estimate is indicative in nature. Thus, it might be so that some of the items mentioned in the estimates do not require to be implemented in the field and some of the items need to be implemented more than once, repeated or enhanced as per field requirements. Thus, the intending bidders need to quotes the rates accordingly and will have to follow the instruction of Forest Officials only who will have the liberty to change the inner items mentioned in the estimates, without changing the rate or the amount of that particular item. Intending bidder/s is (are) expected to have that flexibility.
- 3. The labour rates etc given in the estimates are as per existing Government Rules which may be revised as per orders in vogue.
- 4. Since the entire plantation work is a time bound activity, its success depend on how timely the work is executed. Accordingly the items are sequential and need to be completed within the specified time as per direction of the Concerned Officials. This should be strictly followed except under certain unavoidable circumstances and after obtaining specific permission from the undersigned or his authorized representative.
- 5. Payment shall be made to the successful bidders only for those items which he/she carried out a field on pro rata basis as per the rate offered by the L1 & as per the instructions of the undersigned or his authorized representatives. Each item of the estimate has a definite timeline, beyond which the item is very difficult to be implemented in the field. Thus, any item, which is not possible to be implemented in the field. Within due time, can only be implemented after having due permission in this regard from the appropriate authority. Successful bidders are required to prepare bill for making payment accordingly. Running bill payment may also be allowed subject to recommendation of the concerned field Officers; Range Officers.
- 6. All tender should note that this tender is for creation work in F.Y 2023-24 & Maintenance of same plantation in 1st Year (Y1) i.e.-2024-25. This Tender floated too much late due to various technical reasons and as per the administrative sanctions. But the plantation creation work is time bound works, so, the concerned Range Officer may have started the work as per estimate before this tender get matured. Under these circumstances the amount of work done by the R.O at field will be deducted from the contract amount to be awarded and accordingly work order to be issued. In that case the successful tenderer will not have any claim to that amount executed by the R.O's at field through ECS mainly.
- 7. In some case, the plantation locations may also vary/changed depending on the field situation. Payment shall be made on pro rata basis based on the lowest rate offered by the successful bidder/s.
- 8. Since the items are very much technical and needs to be implemented properly as per correct Silvicultural technique, understanding of all the items is a prerequisite for the Bidders. In case of any confusion in later part regarding implementation of any item the decision of the undersigned or his authorized representative shall be final & binding.
- 9. Rate quoted below 10% shall be subject to rate analysis which shall require to be provided based on technical grounds to be ascertained by the Tender Committee constituted for the purpose. As this model estimate is made as per Forest Schedule the rate analysis for any quote less than 10 % should be certified by Forest Officer not below the Rank of a Forest Ranger. Rate analysis which is not technically viable shall not be accepted at this end and the candidature of the contractor concerned shall liable to be cancelled at once. No rates quoted above the estimated rate will be entertained.
- 10. From the above analysis, it follows logically that R.A bills shall be admissible in this regard provide the concerned ROs complication works.
- 11. Issuance of work order to the **L1 Bidders** is subject to administrative approval and availability of fund. Similarly, payments of bills are also subject to availability of funds; the undersigned will not be liable in any such of non-payment or delayed payment or cancellation of the tender or any other circumstances.
- 12. The undersigned will always reserve the rights to cancel Tender/Contract at any moment; even after issuance of work-order, without assigning any reason whatsoever.
- 13. All the plantation sites should be kept neat & clean; under no circumstances weeds should create hindrance for the growth of

the planted seedlings. To ensure this regular cleaning of the plantation sites is recommended.

14. Sl no. 13 to 28 with all taxes from the model estimate is made as estimate of this eNIT.

15. The mazdoors those who were to be engaged for plantation creation work(both Sal & QGS) 60% of them should be job card holder.

- 16. The plant inputs like chemical fertilizers, organic manures, insecticides, hormones etc. Of proper brand approved by the undersigned only, should be applied as per amount prescribed in the Model Estimate.
- 17. The model estimate is inclusive of contingency amount. However, the L1 bidder shall have no claim over contingency amount and it shall only be spent as per specific instruction of office of undersigned or concerned Range Officer as per Govt. of West Bengal financial rules in vogue.
- 18. The usual date for handing over the plantation area will be 31/03/2025 subject to **two (2 no.) following conditions; i) the survival percentage to the seedlings should be more than 98% & ii) the seedlings height should reach 3-5 ft.** Except under special conditions with proper justification which should be recommended by the concerned Forest Officer except which pending amount may get forfeited in addition to other sanctions as deems fit.

C. Interpretations:

- (i) In constructing these conditions, the specifications, the schedule of quantities, tender and Agreement, the following words shall have the meaning herein assigned to them except where the subject of context otherwise requires:
 - a. The term EMPLOYER/AUTHORITY shall mean Divisional Forest Officer, Rupnarayan Division, West Bengal, and include its successor and assigns or the Officers authorized to deal with any matters which those presents are concerned on its behalf.
 - b. The term REPRESENTATIVE shall mean Authorized Official of the Divisional Forest Officer, Rupnarayan Division, West Bengal.
 - c. CONTRACTOR shall mean the firm or company or person whose tender has been accepted by the employer and includes his (their) heirs, legal representative assigns and successors.
 - **d. SITE** shall mean the site of the contract work including any erections thereof and any other land adjoining thereto (inclusively as aforesaid allotted by the Employer for the contractor's use).
 - e. This **CONTRACT** shall mean Articles of Agreement, these conditions, the schedule of quantities, the general instructions to the Contractor, the specifications, the drawings / maps and correspondences by which the contract is added, amended, valued of modified in any way by mutual consent.
- (ii) **ACT OF INSOLVENCY** shall mean any act of insolvency as desired by the Presidency Towns Insolvency Act or the Provincial Insolvency Act or any amending statutes.
- (iii) THE WORKS shall mean the work or works to be executed or done under this contract.
- (iv) **The DRAWINGS / MAPS** shall mean the drawing/map or drawings/maps mentioned in NIT and any modifications of them approved by the Employer or any further Working drawings/maps or sketches by the Employer or any further working drawings/maps or sketches which may be furnished or approved in writing by the Employer.
- (v) The **SPECIFICATION** shall include the plantation specification and general specifications forming part of this contract.
- (vi) The **SCHEDULE OF QUANTITIES**, **BILL OF QUANTITIES** shall mean the Schedule or Quantities as specified and forming part of contract.
- (vii) The PRICED SCHEDULE OR QUANTITIES shall mean the schedule duly priced.
- (viii) **NOTICE IN WRITING or WRITTEN NOTICE** shall mean a notice in writing typed or printed characters sent (unless delivered personally) or otherwise proved to have been received by Registered Post to the last known private or business address as registered office of the addressee and shall be deemed to have been received when in the ordinary course of post it would have been delivered. If the employer feels that the contractor (who has signed the agreement) should himself come & personally meet to the employer for necessary discussion in connection with the work; he must contact personally. In case the contractor (not his authorized person) does not meet personally and intentionally avoids or do not reply the letter, the matter will fall under the breach of the contract. The work progress should be in the proportionate of the time frame set forth for the completion of the works.
- (ix) The term **APPROVED, DIRECTED or SELECTED** mean the approval direction or selection of the Employer and where ever the words ALLOW, INCLUDE, and PROVIDE occurs the cost of the items is as the risk of the contractor. **COMPLETION** shall mean that the plantation in the opinion of the Tender Inviting Authority; completed in all respect.

(x) **WORDS** imputing persons include Firms and Corporation, words imputing the singular only also the plural and vice/versa where the context so requires.

INSTRUCTION TO BIDDERS (ITB)

1. General Guidance for e-Tendering

- Only downloaded copy of the B.O.Q. are to be uploaded quoting the rate, virus scanned & digitally signed by the contractor.

- While evaluation, the Tender Opening Authority may summon the tenderers and seek clarification / information or

 within the stipulated time frame, their proposals will be liable for rejection.
- **6. Final publication of summary list of technically qualified tenderers:** Date of opening of financial bid will be intimated in the final summary list, after completion of all procedural formalities.

7. Opening and Evaluation of Financial Proposal:

- Financial proposals of the tenderers declared technically eligible by the Tender Evaluation Committee (TEC) will be opened by the Tender Opening Authority or his authorized representative electronically from the web portal as per the date and time schedule mentioned in the N.I.T. using their Digital Signature Certificate.
- Intending technically qualified tenderers are encouraged to be present during this process.
- The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present at that time.
- After evaluation of Financial Proposal, the Tender Opening Authority may upload the final summary result containing inter-alia, name of contractors and the rates quoted by them against each work, provided Tender evaluation committee is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate.

8. Procedures to be followed when one / two technically qualified tenderers participated in any tender:

- Intending Tenderers at their own cost and risk are encouraged to inspect the site of work and get themselves thoroughly acquainted with the local condition and all factors which may affect their rates. - **16. Verification of credentials/onsite projects:** Before issuance of the work order, the Tender Accepting Authority may verify the credential and other documents of the lowest Tenderer, if found necessary. After verification, if it is found that such documents submitted by the lowest Tenderer is either manufactured or false, work order will not be issued in favour of the Tenderer under any circumstances and legal action will be taken against him.
- 17. **Cancellation of Tender:** The Divisional Forest Officer, Rupnarayan Division, W.B. reserves the right to cancel this N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

Failure to do so, penal action against the Agency will be imposed by the Government as deem fit. The Agency will have to quote his rate considering the above aspect. Also the Prospective Tenderers shall have to execute the work in such a manner so that appropriate service level of the work is kept during progress of work and the period of maintenance.
