5. Disposal of forest produce harvested during the F.Y. 2017-18.
6. Discussions on the decision taken in the meeting held on 13.06.18.
7. Miscellaneous.

Each DFO will prepare a Power Point Presentation covering the following points :-

1. Total forest produce harvested during the F.Y. 2017-18 vis-à-vis disposal of forest produce through e-auction and the produce remaining in the depot as on 01.09.18.
2. Total forest produce received from other sources (other than the felling operation) vis-à-vis disposal of forest produce through e-auction and the produce remaining in the depot as on 01.09.18.
3. Problems faced if any
 - i) while fixing the reserve price of the depot lots ;
 - ii) while making payment of usufruct to JFMCs
 - iii) any problem related to felling operation

Each DFO/DM who has undertaken the felling operation will be given an opportunity to make a presentation.
