The Directorate is receiving fund, from the RKVY Scheme, to the tune of Rs. 10.0 crore to Rs. 13.0 crore per year. The fund is routed through WBSFDA to the implementing Divisions covering all the Circles. The fund is being utilised for Soil-moisture Conservation Works in general and other specific items of works as per the requirement of the Directorate.

During 2016-17 and 2017-18 the major thrust has been on creation of infrastructures for Central Nurseries, with a view to modernise our QPM production, and to do away with all field nurseries. The details of allotments is given below:-
